SUNDOG ARTS SOCIETY

OBJECTIVES

- 1. To organize and present Crafts and Music Fairs, and other similar cultural events, for the purpose of making the work of local crafters, artists and musicians available to the general public of Saskatoon.
- 2. To present said events on a non-profit basis.
- 3. To retain any monies collected at such events which may be in excess of the costs of production of said events, and to administrate said monies towards the production of future events of similar nature.
- 4. To solicit and administrate other monies which may be obtained in support of the Sundog Arts Society.
- 5. To do all such other things as are incidental or conductive to the attainment of these objectives.

BY-LAWS

Article 1 – Membership

- 1. Any person may become a member of the Society upon written application for membership and approval of their application by the Executive.
- 2. Any member may withdraw from the Society at any time by written notice to the Secretary of the Society or by not renewing membership.
- 3. Any member withdrawing from the Society under the above provisions is not entitled to a refund.

Article 11 – Membership Fees

1. The yearly membership fee as on the application form shall be due on the closing date of the Faire.

Article 111- Executive

- 1. The affairs of the Society shall be administered by a minimum of five and maximum of ten Executive Members in consultation with the general membership.
- 2. Executive Members shall serve for a period of five years at which time elections will be held at the Annual General Meeting.
- 3. Three Executive Members personally present shall constitute a quorum.
- 4. The President of the Society shall preside at all Executive and General Meetings, unless he/she chooses another Executive Member to preside in his/her absence.
- 5. The Treasurer shall be the custodian of all Society funds, and pay bills that are approved in the Budget.
- 6. Executive Members missing more than four consecutive meetings would be considered delinquent and removed from the Executive.

Article 1V – General Meetings

- 1. The Annual General Meeting shall be held in March or April of each year on a date to be decided by the Executive. Membership to be notified no less than ten (10) days prior to the meeting.
- 2. The President shall call a General Meeting when requested in writing by at least five members.
- 3. Notice shall be given to the members by such means as the Executive decides upon.
- 4. Fifteen members personally present shall constitute a quorum.
- 5. Voting shall be by show of hands, unless three members request a ballot.
- 6. Meetings to be guided by Robert's Rules of Order.

Article V – Custody and Use of the Seal

1. The Seal of the Society shall be in the custody of the Treasurer.

Article V1 – Amendment of Bylaws

1. These by-laws may be amended only in the manner provided in the Non-Profit Corporations Act.

Article V11 – Winding Up

1. Subject to Section 184 of the Non-Profit Corporation Act, on dissolution of the Society, its properties and assets shall, after payment of all liabilities, be donated to such charitable, educational or cultural purposes as may be decided by the Executive.
